






# Landscape management, rural economies and the CAP: evidence and perspectives

#### **Purpose and Scope**

Based on the Ecosystem Service approach, the Claim Project aims to provide insights into the potential contribution of landscapes to the creation of added-value for society in rural areas. In particular, the focus of CLAIM is to better understand the mechanisms and impacts of agricultural landscape management on regional socio-economic competitiveness. The specific goal of the project is to disentangle cause-effect feedbacks able to trigger valorization pathways at the landscape level. The involvement of stakeholder groups at both the EU and local levels, and an interdisciplinary perspective, are distinctive features of the project.

The purpose of the final conference is to disseminate project results that are of particular relevance to target EU institutions and other key stakeholders at the EU level. Academics active in regional development research in Europe and worldwide will be invited to present the findings of the project and to elaborate an agenda for future research on the relationship between landscape management and regional development.
